



## Immigration Guidance Fees

Our fees indicated below are **estimated** and related to our legal fees only. Our fees are varied depending on the uniqueness and complexity of your matter also noting any merits; and subject to the need for disbursements which may involve payments to third party individuals or organisations to include the Home Office, Visa Office, Barristers, and various expert reports (Social Workers, GPs letters, medical legal reports, etc), Translators/Interpreters, and others, as necessary. Upon receipt of full instructions are we able to fix fees for stages of any immigration matter.

In summary, our legal fees cover the following:

- Initial Consultation
- Upon opening a file provision of client care letters including terms and conditions of retainer
- Consideration of supporting information / documentation
- Preparation of Application / Preparation and Conduct of Appeal
- Outcome discussion

**Any disbursements will need to be paid separately.** Examples of disbursements include Home Office fees, Immigration Health Surcharge, which respectively differ for each type of case, Expert Report fees, Translation/Interpreter Services, Court Applications etc. Please note that this is not an exhaustive list and is meant as a guide only, as each case is valued uniquely and by its own complexity.
