



Immigration Guidance Fees

Our fees indicated below are **estimated**. Our fees are varied depending on the uniqueness and complexity of your matter also noting any merits; and subject to the need for disbursements which may involve payments to third party individuals or organisations to include the Home Office, Visa Office, Barristers, and various expert reports (Social Workers, GPs letters, medical legal reports, etc), Translators/Interpreters, and others, as necessary.

Any disbursements will need to be paid separately. Examples of disbursements include Home Office fees which differs for each type of case, Expert Report fees, Translation/Interpreter Services, Court Applications etc. Please note that this is not an exhaustive list and is meant as a guide only, as each case is valued uniquely and by its own complexity.
